Welcome to a cost-effective solution for high-speed printing from mainframe 3270 printer sessions to Novell print queues.

The PRINT/GATE product enables an IBM, PS/2, or compatible computer to direct output from up to 24 host 3270 printer sessions to as many as 24 Novell print queues.

This manual shows you step-by-step how to install the PRINT/GATE software and choose the proper settings for your configuration (Chapter 2).

You should be able to install and use the PRINT/GATE product by following the steps in this manual and the *BARR/3270* manual. However, please feel free to call Technical Support if you have any difficulties.

1. Introduction

PRINT/GATE is a computer-based product that allows you to direct print data from mainframe applications like CICS, IMS, and TSO to up to 24 Novell print queues. Up to 24 printer session LUs can be defined for PRINT/GATE. Most 3270 emulation packages support only a few printer sessions.



PRINT/GATE has all the features of the BARR/3270 product, plus it allows additional printer sessions and gives you the flexibility of accessing many network printers. You can direct your output to any LAN-based or server-based printer on the network. When printing to network printers, output from multiple queues can be sent to a shared printer, or different queues can write to different printers. The following diagram shows an example of assigning network queues to printers.



And it's fast. Printing with PRINT/GATE is four times faster than Novell captures.

With PRINT/GATE, you also are assured of a reliable connection for your printer sessions. In a typical SNA network, 3270 printer sessions are handled by computer workstations connected to a controller or gateway. Printers are connected to only a few of the user computers and are shared by many 3270 users on the network. Each printer requires its computer to be powered on, configured properly, and running the 3270 emulation software successfully. Since these users often reboot or change programs, 3270 users cannot rely on these printers.

With PRINT/GATE on a dedicated computer, your host printer sessions are no longer dependent upon a user's computer. You can print anywhere on the network without having to worry about another user's workstation.

The following diagram shows a sample SNA network configuration with PRINT/GATE.



1.1 Features

PRINT/GATE supports all of the features available with BARR/3270, plus more. The standard 3270 features (printer, display terminal, keyboard, file transfer, communications, and diagnostic features) are discussed in Chapter 2 of your *BARR/3270* manual.

The following additional features are supported by PRINT/GATE.

Support for up to 24 Novell Print Queues

PRINT/GATE can support up to 24 Novell print queues. This is double the number of network print queues supported by BARR/3270. The print queues can be on up to 24 print servers. The Barr software dynamically manages connection to the servers, maintaining simultaneous connection to as many as eight, the maximum allowed by Novell. When a request is made to connect to another server, Barr disconnects from a server that it is not currently printing to and makes the new connection. However, the connection with the default server is always maintained.

Support for up to 24 Host LUs

PRINT/GATE supports 20 more host LUs than 3270 emulation software, allowing you to maintain 24 host printer sessions to service all your mainframe printing needs.

Connection by Host or the BARR GATEWAY

PRINT/GATE can be a standalone station, or it can be a workstation to the BARR GATEWAY. When attached by the BARR GATEWAY, up to 20 printer sessions and 24 Novell print queues are available.

Choice of SNA Protocols

When used as a standalone station, PRINT/GATE can connect to the host by SDLC, X.25, Token Ring 802.2, or COAX/3299. PRINT/GATE can connect to the BARR GATEWAY using ASYNC, IPX, NetBIOS, Token Ring 802.2, or X.25 protocols.

Printer Session Status Screen

The Barr software includes a printer session status screen that lets you monitor the status of the 3270 printer sessions. For each printer LU defined, this screen shows the LU number, LU name, status, application ID, number of lines received, and the destination for the printer output.

Local Sessions

You can also define local 3270 terminal sessions and local printer sessions to PRINT/GATE. However, note that computers usually do not have enough memory to enable more than 24 total sessions, including any local sessions plus the sessions for the network printers.

1.2 Computers Supported

PRINT/GATE is for use only with IBM AT, IBM PS/2 Micro Channel Architecture Models 50 and above, or compatible UL-listed computers that have installation instructions detailing user installation of card cage accessories.

1.3 Requirements

PRINT/GATE requires:

- One of the supported personal computers with at least 640K memory
- DOS version 3.0 or later
- Barr Communications hardware (RS232, V.35, X.21, Token Ring, or COAX for standalone; ASYNC or X.25 for workstation; Barr hardware not necessary for workstation IPX, NetBIOS, or Token Ring connections)

2. Software Installation

Installation Steps

It is usually best to install any communications hardware first, then the software. Follow these steps when installing PRINT/GATE.

1. **Hardware Installation** – Install the Barr communications hardware, if any, that came with your package. Refer to the Barr communications adapter manual for instructions.

For the Token Ring connection, no adapter manual is supplied. A Token Ring key is supplied, however, with the standalone software version. Simply plug the Token Ring key into a parallel (LPT) port on the computer.

If the connection is by BARR GATEWAY, Barr communications hardware is supplied only with the X.25 connection.

- 2. **3270 Printer Session Parameters** Define the 3270 printers. Refer to Section 2.3 of this manual.
- 3. **Devices and Printers** Define the network print queues to the Barr software. Refer to Section 2.4 of this manual.
- 4. **Assign Devices** Assign the output from the 3270 printer sessions to the network print queues. Refer to Section 2.5 of this manual.
- 5. **Complete the Software Installation** Finish entering the remaining installation parameters, according to the instructions in Chapter 5 of the *BARR/3270* manual.
- 6. **Host Definition** This manual lists the parameters you need to define PRINT/GATE to your host. The host definition is discussed in detail in Section 5.3 of the *BARR/3270* manual.

2.1 Load Software from Diskette

Follow these steps to install the software from the floppy disk provided.

- 1. Insert the Barr software disk into drive A.
- 2. At the DOS prompt, type A:install.

c>A:install

- 3. Follow the on-screen instructions for loading the software into directories on your computer.
- 4. When the software is loaded, the Installation Description menu for the Barr software displays. Follow the instructions in the remaining sections of this chapter for entering the configuration parameters.

2.2 Installation Description

This chapter covers the PRINT/GATE parameters you specify during software installation to define 3270 printer sessions and direct output to Novell print queues. The *BARR/3270* manual discusses installation and operation of the 3270 features of the software provided.

2.4 Devices and Printers

Next, define the network print queues to PRINT/GATE from the **Devices and Printers** menu. This information is also covered in Section 5.4 of the *BARR/3270* manual. It is repeated here for your convenience.

Network Printer Options

Option	Description

When printing files using the network device type Device Driver, if you enter a file name as the device name, any files with duplicate names will be renamed using Barr's automatic generation of numeric file extensions. Barr will assign the first file with a duplicate name an extension of .001, the next file with that same name will have extension .002, and so on. (If extension .999 is reached, a #1 will be placed at the end of the file name and the extension sequence will start again, continuing until mvfile#10.999 is reached. For example:mvfile.999,

On every printer, you can manually set lines-per-form and lines-per-inch. As an alternative to manually making these adjustments, the Barr software automatically sets the lines-per-form and lines-per-inch for you if you use one of the printers listed on the following screen.

Only the lines-per-form is set when you use the **Printronix P300**, **P600**, or the **DAVFU**, **Dataproducts** option. The lines-per-inch is not set and should be set manually.

Printer Control Data for Network Printers

It is important to send an appropriate reset string at the beginning of each file printed on a network printer. These printers print data from many different applications, and data from the Barr software may not print correctly unless the proper reset string is sent.

Printer reset strings should be entered in the **Printer control data** table for the NET devices. Refer to Section 5.4 of the *BARR/3270* manual for a complete discussion on **Printer control data**.

Complete NET Device Definitions

Repeat the steps in this section (2.4) for each NET device.

Under **Assign Devices**, the **NET** devices can now be used the same as any other destination device. Device assignment is discussed in Section 2.5 of this manual.

2.5 Assign Devices

After you have completed the definition for the 3270 printers, you need to assign output from the printer sessions to the destination queues on the network. The features of the **Assign Devices** menu are explained in detail in Section 5.5 of the *BARR/3270* manual. This section covers assigning the devices that are unique to PRINT/GATE.

Enter the remaining installation parameters according to the instructions in Chapter 5 of the *BARR/3270* manual. Remember to select **Exit and Save Changes** from the **Installation Description** menu when you are done in order to save the configuration parameters.

To re-enter the Installation Description at a later time, at your DOS prompt, type:

2.6 Buffer Allocation

When defining a total of 10 or more 3270 sessions, it probably will be necessary to increase the buffer allocation in the Barr software.

From the Installation Description screen, select Tuning Data. The Tuning Data menu will display.

 Enter the desired values for DOS buffers in Memory allocated for buffers and extended memory in Extended memory allocated for buffers.

Depending on the total number of sessions you define, you may need to define as much as 150,000 for Memory allocated for buffers and 150K for Extended memory allocated for buffers. With 10 or more sessions, we recommend you define this much initially. Then, while utilizing the maximum number of sessions you defined, you can monitor free buffer space to determine whether these values can be reduced.

Buffer usage can be monitored during operation from the Communications Statistics screen. From the Operation menu, select Advanced, Diagnostics, then Communications Statistics.

2.7 Sample PRINT/GATE Configuration

The following example shows how the PRINT/GATE installation screens would look with the following configuration.

Five CICS, three IMS, and six TSO printer sessions will be defined, for a total of 14.

The printer sessions will write to queues based on their application. Each CICS session will write to a different queue on one server, each TSO session will write to a different queue on another server, and all IMS sessions will write to the same queue on a third server. Thus, a total of 12 queues on three servers will be needed.

2.8 Host Definition

After you have entered the **Communication Link** parameters, as described in Section 5.3.0 of the *BARR/3270* manual, the host definition parameters will display on the computer screen. The PRINT/GATE host definition will be similar to a BARR/3270 definition for your particular host connection, with these differences:

- The value for MAXLU will be larger, reflecting the number of LUs defined.
- The host LU names and the LUNAMEs defined in the Barr software must match.

Refer to Section 5.3.0 of the *BARR/3270* manual for a detailed discussion of the host parameters.

Physical Unit Definition

Local 3270 terminal sessions should be defined to your host first, followed by any local 3270 printer sessions, then the 3270 printer sessions for the network printers. Remember that the LU names in your host definition and the LUNAMEs defined in the Barr software must match.

3. Operation

Once you have configured the PRINT/GATE software, you simply need to run it. Basic startup and device assignment steps are discussed in this chapter. Refer to chapters 7 and 8 of your *BARR/3270* manual for detailed startup and operation instructions.

3.1 Startup

To run the PRINT/GATE software, at your DOS prompt, type the command PRT_GATE.

c>PRT_GATE

3.2 Assign Devices

During operation, you can make changes to the routing of printer session output. Remember that any changes you make here are only temporary. Permanent changes must be entered in the Installation Description.

To reach the Assign Devices menu during operation, from the Operation menu, select Advanced, then Assign Devices.

You can dynamically alter the destination for printer session output or temporarily suspend output from printer sessions. Any printer sessions you defined in the installation program but did not assign to a network queue destination will default to **SUSPEND**.

3.3 Monitoring the 3270 Printers

The 3270 printer sessions can be monitored from the Printer session status screen.

For each network printer LU defined, this screen shows the LU number, LU name, status, application ID, number of lines received, and the destination for the printer output.

You can reach the 3270 **Printer session status** screen from the **Operation** screen by using any of three methods:

- Select Advanced, then Sessions, and then Printer.
- Hold CTRL+ALT and then press P.
- Hold CTRL+ALT and then press the space bar to step through the sessions until you reach the status screen.
